Foreword from Wong Chen

My dear Subangites,

This is my third newsletter to you as the Member of Parliament for Subang. It has been a very busy half-year for me. Broadly speaking, I have been focusing on Parliamentary reforms, Public Accounts Committee (PAC) hearings, diplomatic engagements and the caucus working group meeting of ASEAN Inter-Parliamentary Assembly (AIPA). On the community front, my office continues to professionally deal with your complaints and attend numerous community events. We have also embarked on a RM2.55 million project to repair all 51 public schools in Subang.



Parliamentary Updates

In January 2019, I joined the Speaker of Parliament for a week-long visit to IJK Parliament. We meetings with MPs and UK Parliament officials on all matters to do with the principles, laws. rules administration of the UK Parliament. The visit galvanised my resolve to continue to push the agenda Parliamentary reforms in Malaysia. We only had one sitting in the last six months, and I am happy to report that I attended every day of the March parliamentary sitting. I am pleased that my speech in reply to the Yang di-Pertuan Agong's speech, supported by both sides of the divide and garnered a rather wide viewing.

YB Nurul Izzah and myself had a public disagreement with the Prime Minister, when he did not want the PAC to be headed by an Opposition MP. This dispute dragged on for about three weeks between March and April 2019. In the end, the Prime Minister relented and YB Noraini Ahmad of UMNO was appointed to head the PAC. In the last six months, the PAC has had ten hearings and four housekeeping sessions to write our reports.

In addition to the above, I have assisted Parliament in greeting MPs from Germany, Singapore, and Bhutan. I was also tasked to chair the working group Climate Change at the very recent (June 2019) AIPA caucus, held in KL. The event saw some from **ASEAN** 30 MPs participating. To prepare for the event, I spent about eight weeks conducting deep policy research on the issue of climate change, focusing primarily on carbon pricing. I believe the caucus was a success and that we made a positive influence the on participating ASEAN MPs.



Diplomacy

The last six months have been very busy for me on the diplomatic front. In view of the lack of reforms in Malaysian politics, I have decided to redirect some of my focus on expanding my diplomatic network. On that front, I have had meetings with the Ambassadors and High Commissioners from the EU, Norway, Cuba, Nederland, Colombia, Canada, Singapore, Taiwan, Uruguay, France, Denmark and Italy. Again, I had 27 diplomatic engagements over the period of 6 months, whereby I hosted dinner in my house on 14 occasions.





National Economic Issues

The Malaysian economy has continued to underperform in the last six months. On the macro side, the revival of the controversial ECRL project may help inject foreign capital inflow in the next six months.





However, I am less than convinced that this project is truly viable or effective as a long-term economic generator. On the consumption front, we witnessed a relatively quiet Chinese New Year and Hari Raya. On a brighter note, prices of goods have stabilised and prices of some essential items have dropped marginally. Wages remain unchanged and public unhappiness is becoming more obvious.

The US-China trade war continues to be an issue but with the recent US-Iran tensions, we may see stronger oil revenues in the coming months. My most critical issue on the economy, which is an open disagreement with my own government, is the lack of institutional political reforms. The Malaysian economy is a completely politicised economy and unless we make good on upholding the separation of powers, and implement a robust system of checks and balances to the excessive powers of the Executive, our economy risk being stuck in the old crony capitalism model.



Community Work

On the community front, we have handled 546 new cases in the last 6 months. I have attended 38 community events. We have also embarked on our big annual project and this year we are committed to repair all 51 public schools in Subang. Each and every school will receive an equal amount of RM50,000. We launched the project in March but the land office that handles these projects are severely understaffed and as such progress has been slow.

In view of the above, I ask all the PIBGs to be a bit more patient as my office will continue to expedite these projects.



Lastly, I want to thank

YB Ng Sze Han, YB Michelle Ng, and the hardworking councillors and JKP members

for the continuing good work in serving Subang.

I would also like to thank my officers, interns, and volunteers for their best efforts in the last six months. I want to particularly thank Tina Lai for her two years of dedicated service to the P104 office; she will be pursuing a new career as a lawyer. I would also like to welcome Kevin Ling, my new officer to the P104 family.

My very best wishes and may the next six months be productive and prosperous to all.



Parliamentary Updates

The March-April sitting was the first parliamentary session for 2019. One hopeful outcome was the appointment of YB Noraini Ahmad as the new head of PAC. Initially, following the Prime Minister's announcement to retain Bersatu's YB Ronald Kiandee as PAC chairman, several backbench MPs including YB Wong Chen and YB Nurul Izzah wrote to the Prime Minister urging him to fulfill the Pakatan Harapan manifesto pledge to appoint an opposition MP as chief of the committee. After an outcry over the issue, the Prime Minister made a call to replace the Beluran MP with the Parit Sulong MP from BN. A small victory—also for gender equality, another manifesto pledge—but a victory nevertheless.

In his royal address, the Yang di-Pertuan Agong touched on the core challenges facing the country and the people. In response to the King's speech, YB Wong Chen agreed that some of these challenges are the rising cost of living and the lack of reforms in anti-corruption and parliamentary administrative processes.





YB Wong Chen continued to emphasise the urgent need for the Pakatan Harapan government to carry out reforms to improve the economy and well-being of the people. YB Wong Chen is pushing for the full restoration of the separation of powers to exercise checks and balances primarily on the executive.

Our office collaborated with the Cuban embassy to arrange for a talk in Parliament on the Cuban national health service. It was an exciting experience for both the officers and interns to work closely with HE Ibete Hernandez, the Cuban ambassador. The talk was accompanied by a Q&A session moderated by YB Wong Chen and gave many MPs a useful insight into Cuban healthcare. YB Wong Chen concluded that with the right policy, Malaysia too can deliver world-class healthcare at lower costs.



YB Wong Chen has attended a total of 14 PAC Meetings during this sitting.

Policy Paper Highlights

Combining our experience and thorough research, our office has prepared a paper titled

'The Cost of Statelessness"

This paper explores some fundamental issues arising out of statelessness among those born in Malaysia and children of Malaysian parents. Furthermore, it provides a good estimate on the cost of statelessness to the economy when rightful citizenship is denied.

The main findings and conclusions are as follows:

- The estimated economic loss from denying citizenship amounts to RM 6 billion per annum; and,
- With the right political will, the matter of 300,000 stateless persons can be resolved without an increase in departmental budget and within two years.

We further suggest solutions to resolve the issue of statelessness by focusing on, but not limited to:

- · amending of the Adoption Act 1952; and,
- introducing DNA testing as conclusive evidence.

By conclusively resolving citizenship cases, Malaysia will yield much higher economic, social and health benefits without incurring any additional administrative costs. If you're interested, please check out our website at www.wongchen.com/reports.



Community & Welfare

Since 1st January 2019, we have handled 546 cases.



In a period of six months, we learned a common pattern regarding the complaints. These complaints are best explained in three categories;

(a) citizenship, (b) legal cases, and (c) welfare assistance.

Below, we share some notable cases according to respective categories.

The bulk of files sit behind the officers' desks, until we finally receive a reply, an update, or a notification of citizenship approval. Unfortunately, receiving a reply from the relevant ministries is a rare occurrence.

As of 25/6/2019, we have only received not more than 12 written replies stating the outcome, or updating the case. We understand that some of our constituents are frustrated, the officers are doing their best to frequently follow up on individual cases.



On citizenship, our office currently handles 65 cases

Besides that, many of our constituents are caught in legal cases. These range from unfair termination of employment, private disputes, or fraudulent cases. Our superhero volunteer lawyers have been providing legal advice every Wednesday night. However, our constituents need to understand that our volunteer lawyers only provide advice on laws, they do not services for provide legal professional and ethical reasons.

A Mother's Cry

Amongst the many welfare cases we have handled, Ms L's harsh situation captured our attention. Ms L became a single mother when her husband left her 14 years ago and never came back. Her first son got into an accident last year and was bed-ridden ever since. He was the only breadwinner of the family. Her whole life was turned upside down.

Her second son was forced to leave medical school due to financial constraints; he has since also abandoned the family.

We learned that Ms L has also been suffering from various medical problems. Adding to her responsibilities, Ms L is taking care of her other two children - aged 15 and 17. It is sad to note that Ms L is just one of the many cases we have dealt with.





We have allocated RM 2.55 million for the infrastructure repairs of all 51 schools in the Parliament Subang constituency.

The following pie chart depicts spending on welfare to the hardcore poor, associations, pledges, Jom Shopping projects, and infrastructure projects.




Figure 1. Allocation Spent as of 31st June 2019.
