# FOREWORD FROM WONG CHEN

My dear Subangites,

This is my second newsletter to you as the Member of Parliament for Subang. Despite winning the General Election on 5th May 2018, I only assumed my official position on 16th July 2018. As such, we could only start office once the financial allocations for our office were provided. The immediate task then was to rent and then renovate a new office in Kinrara, which took us about two months. We finally opened our doors to you on 1st October 2018.

## PARLIAMENTARY DUTIES

I am very happy to report that I attended two parliament sittings; (a) from 16th July to 16th August 2018, and (b) from 8th October to 11th December 2018. In accordance with my duties, I have attended every parliament sitting, except for one day where I was in Kwangju, South Korea for a human rights conference. In total, I delivered seven keynote speeches, mostly focusing on the national budget and the SST. I am a bit dismayed to report that in the last two parliament sessions, the new government has yet to deliver any significant democratic and anti-corruption legislation.

As we enter the new year of 2019, my parliamentary duties are becoming more set. I was appointed to the Public Accounts Committee (PAC) in October 2018, where I have been tasked to look into allegations of corruption and wastage of government and statutory bodies. I have attended nine PAC hearings and had the opportunity to question former PM, Dato' Seri Najib Razak and other senior civil servants and officials. I am also committed to pushing for wide ranging parliamentary reforms. To that end, I have travelled to Norway on the invitation of the Norwegian Government to look at their Standing Committee system. I have also travelled to Singapore and South Korea to look at anti-corruption, human rights, and better governance structures. For 2019, I will be pursuing the same agenda so that we can form fully functioning standing committees to check corruption and abuses of power.

## POLITICAL ISSUES

The initial public euphoria from GE14 has somewhat deflated. There are many like-minded Members of Parliament who are working towards systemic reforms. But at the same time, the implosion of UMNO and the defections of MPs to BERSATU are very worrying developments. My office will continue to oppose the acceptance of these defectors and push for greater political transparency and accountability.

## NATIONAL ECONOMIC ISSUES

The Malaysian Economy, in the last three months has not been stellar due to the political changes and revelations of higher-than-expected national debt. It is also true that foreign funds have been leaving our shores, but at the same time, there have been renewed interests of other investors waiting to see wider democratic space in Malaysia. The overall outlook is still undecided but can be greatly improved, if we deliver fully on better governance and democratic reforms in 2019.

The 2019 budget seeks to tap the reserves of Petronas to fund rebates on GST and income tax. If the fall in oil prices continues, it appears that we may have to recalibrate the budget in the coming months. The US-China trade war continues to be an issue and we may have to brace for an emerging market slowdown. The stock markets are underperforming and our primary commodities and manufacturing sector are also not doing very well. That being the case, 2019 will require greater commitment on governance and better planning on budget allocations.

## COMMUNITY WORK

On the community front, we have handled 654 cases from 2nd January to December 31st 2018. We have also prepared a full report on the state of schools in Subang and are now gearing up to allocate RM200,000 to carry out repair works on as many schools as we possibly can in 2019. We have asked the Ministry of Education to do their part, failing which, we will kickstart the self fund process with our own community allocation. This means that we will have to scale back on other Project Kecils while we focus on making sure that the schools our children attend are safe and sound.

Lastly, I want to thank YB Ng Sze Han and YB Michelle Ng, my two ADUNS, for doing excellent community engagements, which makes my job as the MP easier. I would also like to thank my officers and interns for producing four important public policy papers in the last six months, and to my volunteers for continuing to support us in serving the community on our weekly service nights. My best wishes to all and once again, a Happy New Year.

# PARLIAMENTARY SESSION UPDATES

---

The July - August 2018 sitting was the first parliamentary sitting after the Pakatan Harapan government won the historic GE14 election victory. It has been a surreal start for everyone at the P104 office, to be part of the coalition government.

The 14th parliamentary sitting started with a grand opening ceremony and speech by the Yang di Pertuan Agong, followed by the swearing-in of Member of Parliaments. Apart from guiding and assisting new Member of Parliaments with their maiden speeches, YB Wong Chen also took on the task of helping Mu Sochua, the exiled Cambodian MP. He helped draw media and ministerial attention to the recent political developments in Cambodia. He believes that as a new government the Pakatan Harapan government owes a duty not only to repair our own democracy but that we go further and promote free and fair elections in the ASEAN region.



With regard to the SST bill, YB Wong Chen delivered a speech on the SST while raising important questions on its implementation. He asserted that SST is not a regressive tax like GST and if implemented well, can reduce cost of living. At the same time, he also asked the Minister of Finance to provide a grace period to give businesses to adapt to the new system. He also recommended a periodic review of the list of goods and services frequently purchased by the B40 group, and ensure that these become eligible for SST exemptions. A total of 5 bills are related to the SST transition:

1. GST Bill 2018
2. Sales Tax Bill 2018
3. Service Tax Bill 2018
4. Customs Bill 2018
5. Free Zones Bill and 2018

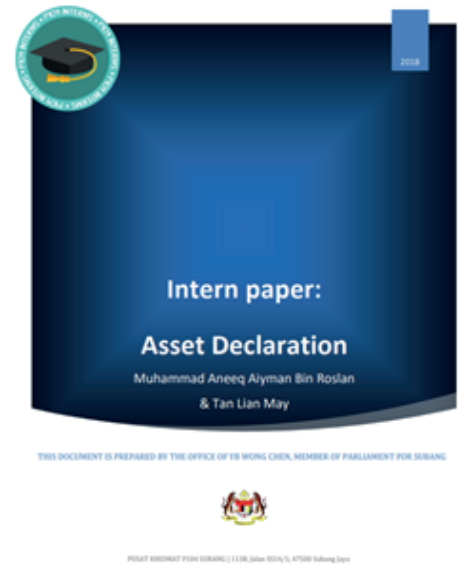
# POLICY PAPER HIGHLIGHTS

After Pakatan Harapan's victory in May 2018, our office embarked on a few research and policy papers. These papers are published on YB Wong Chen's website, [www.wongchen.com](http://www.wongchen.com) and can be downloaded under the section "Reports". Here are a very short summary brief on the policies we wrote in the last 6 months.

## 1. Asset Declaration

This is an intern paper prepared by former interns Aneeq and Lian May.

This paper is an attempt to assess the current inadequate situation of asset declaration in Malaysia and push for further efforts of improving it. This paper stresses that asset declarations of MPs, spouses and adult children should not only be declared to anti-corruption agencies or the Prime Minister, but fully disclosed to the public for citizens and external auditors. In addition, these declarations need to be audited and verified.

## 2. Standing Committees for A New Malaysia

Standing committees are the most important bodies to safeguard the sovereignty of Parliament from excessive Executive powers. In Norway, where the 12 standing committees cover the remit of every ministry, the outcome of a committee's inquiries tends to determine the outcome of parliamentary legislative debates and policies. Malaysian parliamentary democracy would benefit greatly from the adaptation of tried and tested practices.

The paper draws on the information and knowledge gathered from three case studies: Norway, Great Britain, and Malaysia. Although Malaysia has five standing committees empowered by the Standing Orders of Parliament, these powers and their budget are severely limited. The former two systems are much more comprehensive, contributing greatly to better democracy and legislative governance to their respective countries.

### 3. The State of Schools in Parliament Subang

This report was conceptualised after YB Wong Chen attended three government school post GE-14 and noticed the state of disrepair in all three schools. He was informed by the schools that they have had issues with securing funding for maintenance and repair works. Prior to the change in government following GE-14, Wong Chen, as an Opposition MP was not allowed to visit government schools in his own constituency. Based on his first visits post GE-14, he then instructed the officers to do a constituency wide survey of all the schools in Parliament Subang and to produce this paper.

The purpose of this paper is to have a more complete picture of the state of disrepair that both primary and secondary schools face in the Subang Parliamentary constituency. This paper intends to also estimate the total cost needed to rectify these problems. It also discusses other issues faced by these schools, including funding shortage for operating expenditure, an issue that the office came to learn about during the course of the visits.

Wong Chen personally had a lunch meeting and handed the research paper to the Education Minister, YB Maszlee Malik in Parliament. Wong Chen was told that the Ministry will look into the matter.



#### THE STATE OF SCHOOLS IN PARLIAMENT SUBANG

**ABSTRACT**  
The purpose of this paper is to record the state of disrepair in schools in the Subang Parliamentary constituency. This paper intends to also estimate the total cost needed to rectify these problems.

#### Research Background

Our office obtained a list of primary and secondary schools in Parliament Subang from the Ministry of Education's website. Phone calls were then made to each of these schools with subsequent emails sent to request for their participation. In total, there are 52 schools within the constituency. A total of 22 schools gave their consent to participate in this research whilst the other schools did not respond or chose to abstain.



The breakdown of number of participatory schools by our two state constituencies, i.e. Subang and Kinross, can be found in the table below:

### 4. Fiscal Costs of Smoking in Malaysia

This report discloses the tax revenues from tobacco smoking and provides estimates to the fiscal costs of smoking for the year 2018. The conclusions are as follows:

- The estimate tax revenues from tobacco smoking are RM4.15 billion for the year 2018.
- The estimate of total fiscal costs of tobacco smoking is RM5.60 billion. From this estimate, the direct fiscal costs (public healthcare) portion is RM3.72 billion and indirect costs (other lost fiscal revenues related to lost productivity) portion is RM1.88 billion.
- The total tax revenues are short by RM1.45 billion compared to the total fiscal costs of tobacco smoking.
- We note the estimate total economic costs of tobacco smoking to be RM 34.53 billion.
- We need to increase excise duty at a rate of 2% per annum for the next 7 years to arrive at an optimal tax rate on cigarettes.

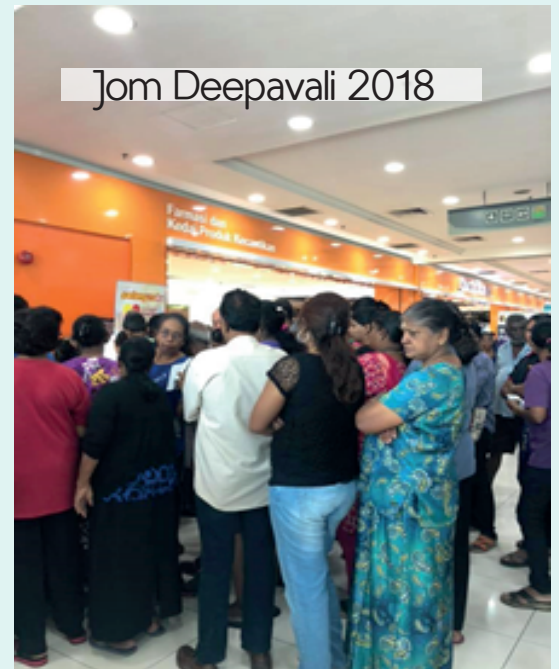
## WELFARE

For community work, we handled 654 cases, since we opened office on 1st October 2018. In a period of 3 months, we noticed a common pattern regarding the complaints. These complaints are basically of three main categories; (a) citizenship, (b) wrongful termination of employment, and (c) other legal issues.

We also carried out in total 8 Project Kecils.

There are several notable welfare programs that we took part in. For the Jom Shopping Deepavali program held on 28 October 2018, organised by the office of YB Ng Sze Han, ADUN of Kinrara, our office contributed a total RM4,450.00 worth of Giant vouchers.

On 23 December 2018, our office contributed again RM2,000.00 worth of Giant vouchers to the Jom Shopping program organised by the office of YB Ng Sze Han, ADUN of Kinrara.

We also gave out individual welfare grants to constituents who are in dire need of financial assistance. Amongst those include a senior citizen couple whose house got burned down by fire and another senior citizen couple who have been financially burdened with dialysis treatment for the husband. There was also a constituent whose family were riddled with hefty medical bills after her husband was diagnosed with cancer, and her daughter had to quit school and work in order to support her family. We also wrote a support letter for her appeal to the hospital to pay her husband's medical fees by instalment or at a discounted rate due to extreme financial hardships the family has been facing.

## RENOVATION

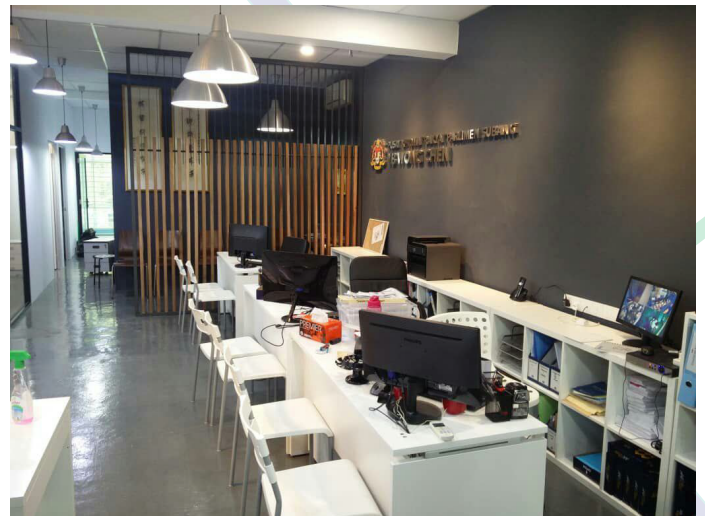

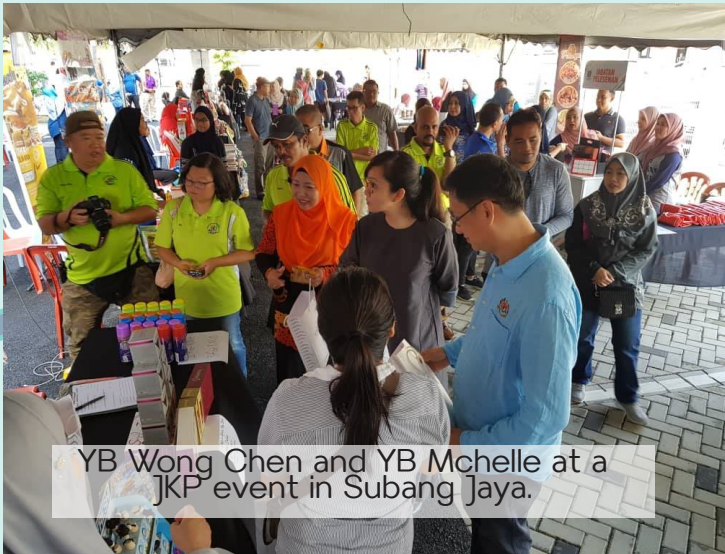

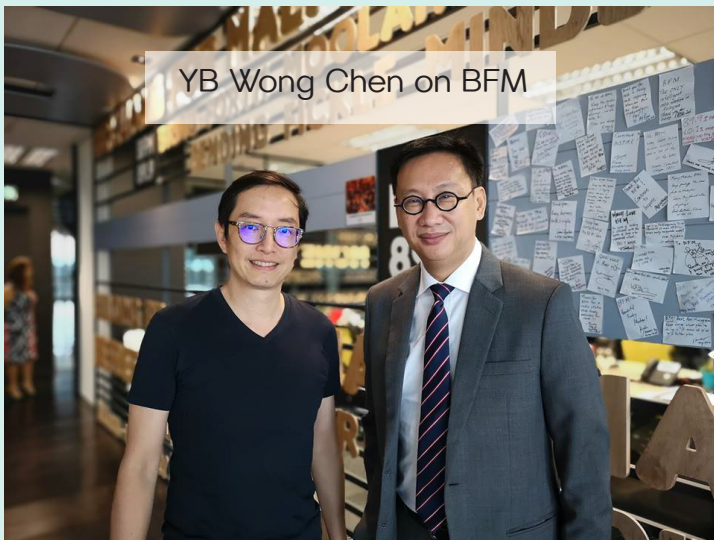

# P.104 ALLOCATION SPENDING

Our office has received a community allocation from the federal government amounting to RM 900,000.00 for the period of July 2018 till December 2018. Initially, only RM 500,000 was received for the year, but RM 400,000 was topped up in the end of November.
